

**TOWN OF SEDGWICK
ORDINANCE #01 OF SERIES 2006**

AN ORDINANCE BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF SEDGWICK, SEDGWICK COUNTY, COLORADO, AND TO BE INCLUDED ON THE BALLOT FOR THE REGULAR MUNICIPAL ELECTION TO BE HELD TUESDAY, APRIL 4, 2006, REQUIRING THE TOWN OF SEDGWICK TO "PUBLISH BY TITLE ONLY" ANY NEW ORDINANCE(S), AMENDED ORDINANCE(S), AND ANY RESOLUTIONS REQUIRING PUBLICATION, IN ACCORDANCE WITH THE REQUIREMENTS OF THE REVISED MUNICIPAL STATUTES OF THE STATE OF COLORADO.

WHEREAS, the Town of Sedgwick is required by law to publish any new Ordinance(s), any Amended Ordinance(s) and certain Resolutions which are introduced, read, discussed, voted on and adopted by the Town Board of Trustees, and;

WHEREAS, in an attempt to limit administrative costs and expenditures where at all possible, this Ordinance #01-2006, would have great cost saving benefits for the Town of Sedgwick and it's Taxpayers,; and;

WHEREAS, the Town Board of Trustees has deemed to put before the Registered Voters of the Town of Sedgwick, this proposed Ordinance #01-2006, as granted by the Revised Municipal Statutes of the State of Colorado, in order to publish any aforementioned items by "Title Only", and;

WHEREAS, the Town Board of Trustees shall make every attempt to keep the residents of Sedgwick, and the general public, informed as to any changes proposed and/or adopted, and the full contents of said item(s), the Town Clerk shall perform the following:

SECTION 1. Post at the Town Hall and in Two(2) other conspicuous places within the city limits of Sedgwick, any proposed and/or adopted Ordinance(s), Amended Ordinance(s) and/or any certain Resolution(s) requiring inspection that have been Published by "Title Only."

SECTION 2. The fore mentioned item(s) in Section #1 shall be posted by the same day as the item(s) is/are to be published by "Title Only" in the newspaper of record for the Town of Sedgwick (At the time of publication of this Ordinance #01-2006, the newspaper of record for the Town of Sedgwick

is the Julesburg Advocate, 108 Cedar St., Julesburg, Colorado). The item(s) posted shall remain posted for not less than Thirty(30) days.

SECTION 3. In the event that the item(s) posted, other than at the Town Hall, are removed and or destroyed by any person other than the Town Clerk, or are in any way obstructed from public view, the Town of Sedgwick shall not be held liable and shall be considered in fulfillment of it's fiduciary responsibility.

SECTION 4. Any person shall be able to read and inspect the item(s) fore mentioned posted and published by 'Title Only' in its entirety at the Sedgwick Town Hall anytime during normal Town Hall business hours. A copy of such item(s) shall be supplied by the Town Clerk upon request and the current applicable fee being paid for administrative expenses as allowed by law.

SECTION 5. Any citizen may make a request to the Town Clerk to be placed on the Agenda for the next Regularly Scheduled Meeting of the Board of Trustees for the purpose of discussing the proposed and/or adopted item(s) in the same manner as currently allowed by the State of Colorado Open Meetings Law.

IT IS HEREBY ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF SEDGWICK, THAT, THIS ORDINANCE, #01-2006, SHALL THEREFORE BE BROUGHT BEFORE THE REGISTERED VOTERS OF THE TOWN OF SEDGWICK, SEDGWICK COUNTY, COLORADO, THE BALLOT PROPOSAL AS FOLLOWS:

BALLOT TITLE

SHALL THE TOWN OF SEDGWICK, BY ORDINANCE #01-2006, BE REQUIRED TO "PUBLISH BY TITLE ONLY" ANY NEW ORDINANCE(S), AMENDED ORDINANCE(S) AND ANY RESOLUTIONS REQUIRING PUBLICATION, WITH THE AFOREMENTIONED ITEMS BEING POSTED IN IT'S ENTIRETY FOR PUBLIC INSPECTION AT THE TOWN HALL AND AT LEAST TWO(2) OTHER CONSPICUOUS LOCATIONS WITHIN THE TOWN OF SEDGWICK. THIS BEING CONSIDERED FOR A REDUCTION OF ADMINISTRATIVE COSTS TO THE TOWN OF SEDGWICK, THEREBY SAVING REVENUES FOR THE TAXPAYERS OF THE TOWN OF SEDGWICK.


